Hauraki Marae Development Grants are for:

- Heritage conservation
- Structural (Exterior and Interior)
- Health & Safety

Applications for Marae grants will open on **1<sup>st</sup> February 2022** and close **31<sup>st</sup> May 2022**.

Grants are available to Marae that affiliate to a Hauraki iwi and must be a legal entity.

Given the limited funds available, priority will be given to those projects that demonstrate collaboration with, and financial commitment from other funding agencies to complete their project.

Applications may be declined if the project has been commenced or has been completed prior to the grant being paid, or it appears that the project is unlikely to proceed within the next year.

All supporting documentation must be provided with the application and be submitted to the office by 5.00pm on the closing date.

The Pare Hauraki Fishing Trust has the sole discretion to accept or decline an application that does not meet the criteria. Its decision is final and no correspondence will be entered into.
